

## **COMPETITION TERMS AND CONDITIONS**

- 1. The Promoter:** The promoter of the competition is Irish Life Health dac (ILH) which is a company registered in Ireland whose registered office is at Irish Life Centre, Lower Abbey Street, Dublin 1 (the “Promoter”).
- 2. Eligibility Criteria:** This competition (“Competition”) is open to persons who are aged 18 years or over and are resident on the island of Ireland only (“Eligible Person”). All employees or agents of the Promoter and their families are excluded from entering the Competition.
- 3. How to Enter:** Eligible Persons may enter the Competition entering via the Irish Life Health Instagram page. Only fully completed entries that are made in accordance with these terms and conditions will be eligible to take part in the Competition. The Promoter accepts no responsibility should persons be unable to enter the Competition for any reason. Only one entry per Eligible Person will be accepted. The Promoter reserves the right to disqualify any entrant for any reason whatsoever in its sole discretion. The Promoter does not accept any responsibility for any loss or damage, cost, expense, or liability suffered or incurred by any person, entrant or otherwise, arising directly or indirectly out of or in connection with this Competition. Eligible Persons may enter the Competition on behalf of a family member or friend but will need to have their consent to do so.
- 4. Closing Date:** The Competition will run from Monday 4<sup>th</sup> November 2024 at 9am (“Opening Date”) until Tuesday November 19<sup>th</sup> 2024 at 11pm (“Closing Date”). The Promoter reserves the right to alter the Opening Date and the Closing Date. The Promoter accepts no responsibility for any delay or failure in the submission of entries or for any entry which is not received by it before the Closing Date for any reason, including for technical reasons. Only entries received through the specified form on the Irish Life Health competition page will be accepted, entries received by any other means including post, email, fax, or hand delivery will not be accepted. Proof of submitting an entry is not proof that the entry has been received by the Promoter.
- 5. Terms of Participation:** All entrants to the Competition are deemed to have accepted these terms and conditions by participating in the Competition.
- 6. The Prize:** The prize for the Competition is (i) a Hertility at home testing kit and (ii) a€250 Brown Thomas Voucher (the “Prize”). Only one Prize can be claimed by any Eligible Person (the “Prize Winners”). The Promoter shall not be responsible or liable for any matter arising out of or resulting from the Competition or the enjoyment of the Prize. The Prize is non-transferrable, and cash will not be offered as an alternative to the Prize. The Promoter reserves the right to offer an alternative prize of equal or greater value should the advertised Prize become unavailable for any reason.
- 7. Selection of the Prize Winners:** The Prize Winners will be selected at random by a draw conducted by the Promoter. An independent observer will supervise the draw. The draw will take place on Wednesday 20<sup>th</sup> November 2024. The decision of the Promoter as confirmed by the independent observer is final and correspondence will not be entered into with any person in relation to the selection of the prize-winners. The PrizeWinners will be notified via direct message on Instagram from the @irishlifehealth account only.
- 8. General:** The Promoter cannot accept responsibility for the acts or omissions of any third parties. The Promoter shall not be liable to any person for any loss or damage howsoever caused, whether direct, indirect or consequential (whether in contract, tort or statutory duty or otherwise) arising out of or in

connection with the Competition and/or the Prize other than death or personal injury caused by negligence of the Promoter and/or the Promoter's respective personnel and/or deceit or fraud by the Promoter and/or the Promoter's respective personnel.

The Promoter reserves the right to withdraw, cancel, suspend, or amend the Competition or the terms and conditions of the Competition at any time, with no liability to any entrant, the Prize Winners or any third party. By accepting the Prize, the Prize Winners grant the Promoter the right to use and publish their name and picture in such media as the Promoter may choose (including but not limited to the Promoter's social media accounts) for advertising and promotional purposes, without payment. By participating in the Competition, you consent to the processing of your personal data in this manner.
